## **Anti Ragging Guidelines**

### **1. Purpose**

The primary objective of these guidelines is to ensure a safe, inclusive, and harassment-free environment for students, as mandated by the **University Grants Commission (UGC) Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009.**

### **2. Definition of Ragging**

Ragging includes any act of physical or mental abuse, bullying, or harassment that negatively impacts the dignity or self-respect of an individual. Examples include:

1. Verbal or physical abuse.
2. Forcing someone to perform tasks that cause embarrassment or discomfort.
3. Discrimination based on caste, religion, gender, or other factors.

### **3. Prohibition of Ragging**

Ragging is strictly prohibited on and off-campus, online interactions.

### **4. Objectives**

1. To create awareness about the harmful effects of ragging.
2. To establish a mechanism for preventing, reporting, and addressing ragging incidents.
3. To promote mutual respect and healthy relationships among students.

1. The Anti-Ragging Committee will conduct a confidential inquiry into the complaint.
2. Based on the findings, appropriate action will be taken.

### C. Disciplinary Actions:

1. **Minor Cases:** Counseling, warning, or community service.
2. **Severe Cases:** Suspension, expulsion, or legal action as per the Indian Penal Code.

## **7. Preventive Measures**

1. **Awareness Campaigns:** Conduct orientation programs and workshops for new students.

4. **Surveillance:** Install CCTV cameras in sensitive areas and conduct surprise checks by staff.

- Report any observed or reported ragging cases to the Anti-Ragging Committee.

### **C. Students:**

- Refrain from participating in or encouraging ragging.
- Report incidents of ragging immediately to the authorities.
